Panel discussion 1

"Problems of Mutual Integration of French and Russian Legislation: Comparative Aspect"

Russia and France have always aimed to build friendly and fruitful relations. Thus, for example, in 2017, at a meeting in Versailles between French President Emmanuel Macron and Russian President Vladimir Putin, the idea of «Trianon Dialogue» emerged to promote the expansion of ties between French and Russian societies in various fields. In 2018, the International Legal Forum «Modern Problems of Law and Economy in Europe and Asia» was held for the first time in Cannes, which eventually became traditional.

The legal order of the two countries, already closely related through the Roman Law reception and historical cultural exchange, are now actively interacting and influencing each other. In the panel discussion, the diplomatic and legal experts will discuss the current legal issues in Russia and France, assess the progress made towards mutual integration and share their latest findings and the results of scientific activities in various branches of law. It will include such critical areas as human rights and freedoms, cybersecurity, resolution of cross-border disputes, migration issues, protection of personal data, regulation of public procurement etc. It appears that comparative jurisprudence methods would help to identify the weaknesses and strengths of the two countries' approaches and to find optimal responses to contemporary challenges.

"EURASIAN ECONOMIC UNION, CHINA AND INDIA: PROSPECTS FOR LEGAL AND ECONOMIC COOPERATION IN THE CONTEXT OF LEGAL INTEGRATION"

In the panel discussion scientists, representatives of Russian and foreign universities, public authorities, business community and international non-governmental organizations will consider the constitutional legal bases for economic cooperation, analyze the various mechanisms for economic cooperation and their legal implementation, examine problems and develop areas for further cooperation to achieve the objectives and standardize legislation.

In the example of the national legislation of Russia, India and China, it is planned to investigate the legal regulation of forms of economic cooperation and implementation practices with a view to the further dissemination of successful experiences. After analysing the development of legal systems, it is expected to formulate prospects for cooperation between EEA, China and India based on equal partnership with a view to meet common interests and resolve issues of economic integration, economic security and geopolitics among the current challenges.

"MODERN PROBLEMS OF APPLICATION OF CRIMINAL LIABILITY AND THE USE OF DIGITAL TECHNOLOGIES"

Nowadays, digital technologies are being incorporated into human life worldwide, becoming inexplicably an integral part of it. Information law is intertwined with both private and public law. Criminal law and Criminal procedure do not constitute an exception.

Digital technologies have brought to the criminal sphere both negative aspects (the emergence of cybercrime, the lack of a conceptual framework, the need for criminalization) and undeniable advantages. Thus, the discussion will focus on the practical aspect of the use of digital technologies in Criminal law: modern scientific advances make it possible to improve investigative activities.

However, the State still faces the challenge of developing a new law enforcement technological response; the digitization of criminal proceedings requires the transformation of traditional institutions of proof, rights of participants in the proceedings, and improvement of the forms of proceedings.

As part of the discussion, speakers will exchange experiences on the use of digital technologies in criminal proceedings in various countries, including in the context of the COVID-19 pandemic.
